- Plan, prepare and deliver quality learning experiences in line with the Australian Professional Standards for Teachers
- Maintain competency and a current knowledge of relevant curriculum programs.
- Create supportive learning environments and effective behaviour management practices.
- Provide for the physical, social, cultural, and emotional wellbeing and safety of students while at the College and assist students in becoming effective leaders within their community.
